

### Article III. Membership

SECTION 2. The membership of NAH shall consist of Individual Members, Family Members, and Life Members.

Will be amended as –

SECTION 2. The membership of NAH shall consist of general Members, Individual Life Members, and Family Life Members.

### Article XIV. Amendment to the Constitution and Bylaws

SECTION 1. Amendments to this Constitution and Bylaws may be proposed by the Executive Committee or by a petition containing signatures of at least ten percent of the members of NAH in good standing.

Will be amended as –

Article XIV. Amendment to the Constitution and Bylaws SECTION 1. Amendments to this Constitution and Bylaws shall be proposed by the Executive Committee or by a petition containing signatures of at least ten percent of the Life members of NAH.

By Laws –

### Article I. Election of Officers

SECTION 2. Each member voting, should be a member of NAH at least thirty (30) days prior to the Election Day, and can cast one vote for each position.

Will be amended as –

SECTION 2. Each member voting should be a life member of NAH (individual or family) at least thirty (30) days prior to the Election Day and can cast one vote for each position.

SECTION 5. The newly elected Officers shall begin their term one month after the election date to allow time to transfer power in this transition period from incumbent to newly-elected Officers.

Will be amended as –

SECTION 5. The incumbent NAH Executive Committee shall duly transfer power to the newly elected NAH Executive Committee within 90 days of the election. The transfer of power shall consist of handover of all NAH documents, assets, bank check books, and transfer of bank signatories.

### Article III. Expulsion of Members

SECTION 1. Any officer or member of the Executive Committee may be expelled by the Executive Committee upon ratification by the Board of Trustees for the reason of nonfeasance, malfeasance,

conduct detrimental to the interests of NAH, lack of adherence with its objectives and ideals, or refusal to render reasonable assistance in carrying out its purposes. If such situation arises, the Executive Committee shall first consult with the Board of Trustees and obtain their concurrence, and then propose and secure the vote of a two-third majority of the Executive Committee at a regular meeting to expel the officer or member from NAH.

Will be amended as -

Any officer or member of the Executive Committee (EC) may be expelled by the EC upon ratification by the Board of Trustees for the reason of nonfeasance, malfeasance, conduct detrimental to the interests of NAH, lack of adherence with its objectives and ideals, or refusal to render reasonable assistance in carrying out its purposes. If such situation arises, a member of the EC can file a signed petition with the Board of Trustees upon getting signatures from one-third EC members. The Board of Trustees shall convene a meeting and secure a simple majority of Board of Trustees members present to proceed with the expulsion. Junior most member of Board of Trustees who is in favor (here in after referred to as "Convener") shall lead the process of expulsion. Convener shall call a meeting of the EC to deliberate and secure a two-third majority of EC members present to formalize the expulsion of the officer or member from NAH.

SECTION 2. The officer or member proposed to be expelled shall be entitled to at least five days' notice in writing from the Executive Committee giving time, date, and place of the meeting. At such meeting, that officer or member shall be entitled to appear before and heard by the Board of Trustees and the Executive Committee.

Will be amended as -

SECTION 2. The officer or member proposed to be expelled shall be entitled to at least fifteen calendar days' notice in writing from the Executive Committee giving time, date, and place of the meeting. At such meeting, that officer or member shall be entitled to appear before and heard by the Board of Trustees.

#### Article IV. Membership Fee Schedule

SECTION 1. Any adult, 18 year and older, who is qualified under Section 1 of the Article III of the Constitution shall pay annual membership dues as follows: Individual Membership \$10.00 and Family Membership \$20.00. The annual Individual Life Membership dues is \$200.00 and the Family Life Membership, \$300. The Family Membership includes the husband, wife, and children below the age of 18 years.

Will be amended as -

SECTION 1. Any adult, 18 year and older, who is qualified under Section 1 of the Article III of the Constitution shall pay annual membership dues as follows:

General Membership (Individual and Family Membership) shall be free of cost. The Life individual Membership due shall be \$250.00 and the Family Life Membership due shall be \$500. The Family

Membership includes the husband, wife, and children below the age of 18 years. Only members with Life membership shall be allowed to vote and participate in Annual General Meeting voting including elections. In case of separation (divorce) in the 'family membership', both husband and wife shall become individual members. Individual member shall pay \$250 to change membership status to Family Membership status.

SECTION 2. The annual membership fee, except the Life Membership, shall be due in January every year.  
Will be amended scrapped.

#### Article VII. Eligibility Requirements for Executive Committee Candidacy

SECTION 1. Any NAH member, 21 year and older, shall be eligible to contest in the election for the position of a member, or Assistant Secretary, or Assistant Treasurer in the NAH Executive Committee.

Will be amended as -

SECTION 1. Any NAH life member, 21 year and older, shall be eligible to contest in the election for the position of a member, or Assistant Secretary, or Assistant Treasurer in the NAH Executive Committee.

SECTION 4. All newly elected officers and members of the Executive Committee are required to obtain NAH Life Membership within 90 days of election.

Will be amended scrapped.

#### Article X. Meetings

SECTION 1. NAH shall hold at least one meeting of the members each year, this meeting to be known as the General Body Meeting.

Will be amended as -

SECTION 1. NAH shall hold at least one meeting of the members each year, known as the General Body Meeting. The announcement of the General Body Meeting shall be sent by the NAH Executive Committee 30 days prior to the meeting with the agenda and a draft of the proposed NAH Constitution and Bylaws Amendment.
